Additional rabies clinic planned in March for dogs, cats and ferrets

MOBILE, Ala. — An extra rabies vaccination clinic has been placed on the schedule for this month. On Saturday, March 10, the Town & Country Animal Hospital will host a clinic from 11 a.m. to 3 p.m. at Semmes Middle School. The clinic is at 4566 Ed George Road. The cost is \$10.

The Mobile County Health Department provides low cost rabies shots for dogs, cats and ferrets during weekend clinics. Here is a list of the remaining clinics planned for Saturdays this month:

- March 10, 1:30 to 4 p.m., Pet Supplies Plus, 803 Hillcrest Road
- March 17, 12:30 to 2:30 p.m., City of Mobile Animal Shelter, 855 Owens Street
- March 24, 1:30 to 3:30 p.m., B&B Pet Stop, 5035 Cottage Hill Road

The cost of the rabies vaccine per pet is \$8 at Pet Supplies Plus. The cost of the rabies vaccine per pet is \$10 at Mobile County Animal Shelter and City of Mobile Animal Shelter. All rabies shots are payable in cash.

Each month, MCHD's Rabies Officer provides hundreds of residents with low-cost vaccines for their pet dogs, cats and ferrets at a variety of locations. The state of Alabama tasks local health departments with providing affordable rabies vaccinations to pet owners. For the month of January, we provided a total of 189 vaccines to household pets.

About Rabies

Rabies is a virus that attacks the central nervous system. It is transmitted from infected mammals to humans and is fatal once symptoms appear. Symptoms of rabies include unusual behavior, irritability, headache, fever, inability to eat or drink, balance problems, circling, seizures, coma, and, finally, death. All warm-blooded mammals, including humans, are susceptible to rabies.

Exposure to rabies may be minimized by eliminating all stray cats and dogs; having pet dogs, cats and ferrets vaccinated; staying away from wild animals, especially those acting abnormally; and not keeping exotic or wild animals as pets, health officials said.

So what happens if an animal is displaying symptoms? Under state law, the owners are required to quarantine their animal for 10 days. The quarantine period is necessary for observation of any clinical signs of rabies infection in the animal.

In 2016, the Mobile County Health Department investigated 527 animal bite cases.
